SECTION 2 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW:

This is a personal care or cosmetic product that is safe for consumers and other users under intended and reasonably foreseeable use. Additional information on toxicological endpoints is available from the supplier upon request.

POTENTIAL HEALTH EFFECTS:

- **Eye:** Contact may cause mild, transient irritation. Some redness and /or stinging may occur.

Water, Cyclopentasiloxane, Propylene Glycol, Talc, Glycerin, PEG/PPG-18/18 Dimethicone, Cetyl Ethylhexanoate, Cyclomethicone, Magnesium Sulfate, Sodium Dehydroacetate, Laureth-7, Arachidyl Behenate, Silica, Trihydroxystearin, Propylparaben, Methicone, Isopropyl Titanium Triisostearate, Methylparaben, Synthetic Wax, Trisodium EDTA, Ethylene Brassylate, Stearic Acid, Titanium Dioxide, Iron Oxides, Mica.

SECTION 4 - FIRST AID MEASURES
