**SECTION 2 - HAZARDS IDENTIFICATION**

**EMERGENCY OVERVIEW:**

**POTENTIAL HEALTH EFFECTS:**

May contain: Iron Oxides, Carmine, Titanium Dioxide, Ferric Ferrocyanide.
