SECTION 2 - HAZARDS IDENTIFICATION

EMERGENCY OVERVIEW:

This is a personal care or cosmetic product that is safe for consumers and other users under intended and reasonably foreseeable use. Additional information on toxicological endpoints is available from the supplier upon request.

POTENTIAL HEALTH EFFECTS:

- **Eye:** Not expected to be irritating to the eye.

May Contain: Calcium Sodium Borosilicate, Calcium Aluminum Borosilicate, Synthetic Fluorophlogopite, Titanium Dioxide, Iron Oxides, Ultramarines, Carmine, Manganese Violet, Ferric Ferrocyanide, Blue 1 Lake, Bismuth Oxochloride, Chromium Oxide Green, Yellow 5 Lake.

SECTION 4 - FIRST AID MEASURES
