Water, Sodium Lauryl Sulfate, Ammonium Laureth Sulfate, Sodium Xylenesulfonate, Acrylates Copolymer, Sodium Chloride, Laureth-4, Dimethicone, Citric Acid, Butyrospermum Parkii (Shea Butter) Extract, Hydrolyzed Algae Extract, Cocamide MEA, Fragrance, Glycol Distearate, Sodium Benzoate, Polyquaternium-10, Disodium EDTA, Polyquaternium-6, Methylchloroisothiazolinone, Methylisothiazolinone, Red 33, Blue 1.

### SECTION 4 - FIRST AID MEASURES
