Water, PVP, Chitosan, Lactic Acid, PEG-40 Hydrogenated Castor Oil, Polysorbate 20, Phenoxyethanol, Fragrance, Methylparaben, PEG-60 Almond Glycerides, Polysorbate 80, Disodium EDTA, Ethylhexylglycerin, Tocopherol.
