<b>SECTION 2 - HAZARDS IDENTIFICATION</b>

Water, Sodium Lauryl Sulfate, Sodium Laureth Sulfate, Cocamidopropyl Betaine, Sodium Chloride, Glycol Distearate, Citric Acid, Sodium Citrate, Cocamide MEA, Sodium Xylenesulfonate, Fragrance, Dimethicone, Sodium Benzoate, Polyquaternium-76, Tetrasodium EDTA, Panthenol, Panthenyl Ethyl Ether, Methylchloroisothiazolinone, Methylisothiazolinone.
