Water, Ammonium Lauryl Sulfate, Ammonium Laureth Sulfate, Sodium Chloride, Dimethicone, Cocamide MEA, Glycol Distearate, Ammonium Xylenesulfonate, Citric Acid, Cetyl Alcohol, Fragrance, Polyquaternium-10, Sodium Citrate, Sodium Benzoate, Disodium EDTA, PEG-7M, Panthenol, Panthenyl Ethyl Ether, Methylchloroisothiazolinone, Methylisothiazolinone, Blue 1, Red 33.

SECTION 4 - FIRST AID MEASURES
