SECTION 2: HAZARD IDENTIFICATION

EMERGENCY OVERVIEW

CAUTION: This product is clear, colored fragranced rock crystals. Direct contact with eyes may cause irritation. Ingestion of large quantities may be harmful. Repeated or prolonged excessive exposure with skin may cause irritation or dermatitis. Intentional inhalation of vapors from product may cause irritation of the throat and lungs with coughing. Keep out of reach of children and pets. No significant environmental effects. Not a fire hazard. Product is stable.

While this product is not considered to be hazardous under OSHA's Hazard Communication Standard (29 CFR 1900.1200), this MSDS includes valuable information that is critical for safe handling and proper use of this product. POTENTIAL HEALTH EFFECTS

NOTE: The acute health effects described below are those which could potentially occur for the finished product. SECTION 4: FIRST AID MEASURES

EYES: Immediately rinse eyes with plenty of water, occasionally lifting upper and lower lids, until no evidence of product remains. Get medical attention if pain or irritation persist.
