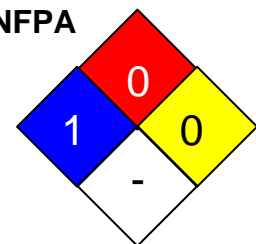
## SECTION 4 -- FIRST AID MEASURES

**Ingestion:** IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water. Induce vomiting only if advised by a physician.
