**SECTION 3 - HAZARDS IDENTIFICATION**

Emergency Overview: Irritant.  
 Potential Health Effects:  
 Eye: May cause irritation.  
 Skin: May cause irritation.  
 Inhalation: Prolonged or excessive inhalation may cause respiratory tract irritation.

**SECTION 4 - FIRST AID MEASURES**

Eye Contact: Immediately flush eyes with plenty of water for 15 to 20 minutes. Get medical attention, if irritation or symptoms of overexposure persists.  
 Skin Contact: Immediately wash skin with soap and plenty of water. Get medical attention if irritation develops or persists.  
 Inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration or give oxygen by trained personnel. Seek immediate medical attention.  
 Ingestion: If swallowed, do NOT induce vomiting. Call a physician or poison control

center immediately. Never give anything by mouth to an unconscious person.

**Other First Aid:** Due to possible aspiration into the lungs, DO NOT induce vomiting if ingested. Provide a glass of water to dilute the material in the stomach. If vomiting occurs naturally, have the person lean forward to reduce the risk of aspiration.

## SECTION 5 - FIRE FIGHTING MEASURES

**Extinguishing Media:** Use alcohol resistant foam, carbon dioxide, dry chemical, or water fog or spray when fighting fires involving this material.

## SECTION 6 - ACCIDENTAL RELEASE MEASURES

## SECTION 7 - HANDLING and STORAGE

**Handling:** Use with adequate ventilation. Avoid breathing vapor and contact with eyes, skin and clothing.

**Storage:** Store in a cool, dry, well ventilated area away from sources of heat, combustible materials, and incompatible substances. Keep container tightly closed when not in use.

**Hygiene Practices:** Wash thoroughly after handling. Avoid contact with eyes and skin. Avoid inhaling vapor or mist.
