Section 4: First Aid Measures

Methods for Containment & Clean-up: Dike area to contain spill. Ventilate the area with fresh air. Handling Procedures: Avoid breathing vapor. Use with adequate ventilation. Avoid contact with skin and eyes. Wash hands after use. Do not expose aerosol containers to heat or flame. Do not incinerate container. Use caution around energized equipment. The metal container will conduct electricity if it contacts a live source. Controls and Protection:

Engineering Controls: Area should have ventilation to provide fresh air. Local exhaust ventilation is generally preferred because it can control the emissions of the contaminant at the source, preventing dispersion into the general work area. 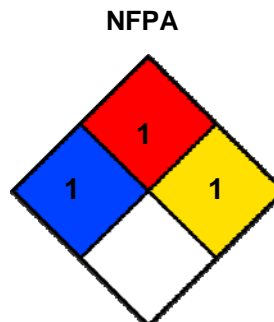
