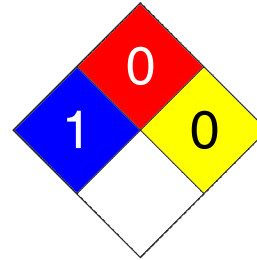

## 2. Hazards Identification

<b>Emergency overview</b>	CAUTION EYE AND SKIN IRRITANT.
