SECTION 4: FIRST AID MEASURES

- As a general rule, in case of doubt or if symptoms persist, always call a doctor.
- NEVER induce swallowing by an unconscious person.

4.1. Description of first aid measures

In the event of exposure by inhalation:

- In the event of inhalation, move patient to the open air. Keep warm and at rest.
- If breathing is irregular or has stopped, proceed with artificial respiration and seek medical attention.

In the event of splashes or contact with eyes:

- Wash thoroughly with soft, clean water for 15 minutes holding the eyelids open.

In the event of splashes or contact with skin:

- Wash the skin thoroughly with soap and water or a recognised cleaner.

In the event of swallowing:

- In the event of swallowing, if the quantity is small (no more than one mouthful), rinse the mouth with water and consult a doctor.
- Keep the person exposed at rest. Do not force vomiting.
- Seek medical attention, showing the label.
- If swallowed accidentally, call a doctor to ascertain whether observation and hospital care will be necessary. Show the label.

SECTION 5: FIREFIGHTING MEASURES

- Flammable.
- Chemical powders, carbon dioxide and other extinguishing gas are suitable for small fires.

5.1. Extinguishing media

- Keep packages near the fire cool, to prevent pressurised containers from bursting.

Suitable methods of extinction

- In the event of a fire, use:
 - - sprayed water or water mist
 - - water with AFFF (Aqueous Film Forming Foam) additive
 - - halon
 - - multipurpose ABC powder
 - - BC powder
- Prevent the effluent of fire-fighting measures from entering drains or waterways.

5.2. Special hazards arising from the substance or mixture

- A fire will often produce a thick black smoke. Exposure to decomposition products may be hazardous to health.
- Do not breathe in smoke.
- In the event of a fire, the following may be formed:
 - - carbon monoxide (CO)
 - - carbon dioxide (CO₂)

5.3. Advice for firefighters

- Due to the toxicity of the gas emitted on thermal decomposition of the products, fire-fighting personnel are to be equipped with autonomous insulating breathing apparatus.

SECTION 6: ACCIDENTAL RELEASE MEASURES

6.1. Personal precautions, protective equipment and emergency procedures

For non fire-fighters

- Because of the organic solvents contained in the mixture, eliminate sources of ignition and ventilate the area.

For fire-fighters

- Fire-fighters will be equipped with suitable personal protective equipment (See section 8).

6.2. Environmental precautions

- Contain and control the leaks or spills with non-combustible absorbent materials such as sand, earth, vermiculite, diatomaceous earth in drums for waste disposal.
- Prevent any material from entering drains or waterways.

- Clean preferably with a detergent, do not use solvents.

SECTION 7: HANDLING AND STORAGE

- Requirements relating to storage premises apply to all facilities where the mixture is handled.

7.1. Precautions for safe handling

- Always wash hands after handling.
- Ensure that there is adequate ventilation, especially in confined areas.

Fire prevention:

- Handle in well-ventilated areas.
- Vapours are heavier than air. They can spread along the ground and form mixtures that are explosive with air.
- Prevent the formation of flammable or explosive concentrations in air and avoid vapor concentrations higher than the occupational exposure limits.
- Do not spray on a naked flame or any incandescent material.
- Do not pierce or burn, even after use.
- Use the mixture in premises free of naked flames or other sources of ignition and ensure that electrical equipment is suitably protected.
- Keep packages tightly closed and away from sources of heat, sparks and naked flames.
- Do not use tools which may produce sparks. Do not smoke.
- Prevent access by unauthorised personnel.

Recommended equipment and procedures:

- Observe precautions stated on label and also industrial safety regulations
- Do not breathe in aerosols.
- Packages which have been opened must be reclosed carefully and stored in an upright position
