SECTION 2: HAZARD IDENTIFICATION

EMERGENCY OVERVIEW

CAUTION: This product is a white to off-white, evenly coated non-woven sheets with a pleasant fragrance. Direct contact with eyes may cause irritation. Repeated or prolonged excessive exposure with skin may cause dermatitis. Keep out of reach of children. No significant environmental effects. Not a fire hazard. Product is stable.

This product is labeled in accordance with regulations administered by the Consumer Product Safety Commission. The use pattern and exposure in the workplace are generally not consistent with those experienced by consumers. Potential Health Effects

SECTION 6: ACCIDENTAL RELEASE MEASURES

Personal Precautions:
