2 – Hazards Identification

Emergency Overview: DANGER! Extremely Flammable liquid and vapor. Vapor may cause flash fire. Harmful or fatal if swallowed. If swallowed, may be aspirated and cause lung damage. May cause eye, skin and respiratory tract irritation. Inhalation of vapors may cause irritation, dizziness and drowsiness. Avoid eye contact. Use only with adequate ventilation. 4 – First Aid Measures

Ingestion (Swallowed): Aspiration Hazard. DO NOT induce vomiting. Call physician, poison control center or the WD-40 Safety Hotline at 1-888-324-7596 immediately.

Eye Contact: Flush thoroughly with water for 15 minutes. Remove contact lenses if present after the first 5 minutes and continue flushing. Get medical attention if irritation persists.

Skin Contact: Wash with soap and water. If irritation develops and persists, get medical attention.

Inhalation (Breathing): If irritation is experienced, move to fresh air. Get medical attention if irritation or other symptoms develop and persist.

5 – Fire Fighting Measures

Extinguishing Media: Use water fog, dry chemical, carbon dioxide or foam. Do not use water jet or flooding amounts of water. Burning product will float on the surface and spread fire. Cool fire exposed containers with water.

Special Fire Fighting Procedures: Firefighters should always wear positive pressure self-contained breathing apparatus and full protective clothing. Cool fire-exposed containers with water.

Unusual Fire and Explosion Hazards: Extremely Flammable liquid and vapor. Vapors can cause a flash fire. Vapors are heavier than air and may travel along surfaces to remote ignition sources and flash back. A vapor and air mixture can create an explosion hazard in confined spaces.

6 – Accidental Release Measures

Wear appropriate protective clothing (see Section 8). Eliminate all sources of ignition and ventilate area. Contain and collect liquid with an inert absorbent and place in a container for disposal. Clean spill area thoroughly. Report spills to authorities as required.

7 – Handling and Storage

Handling: Avoid contact with eyes. Avoid prolonged contact with skin. Avoid breathing vapors or aerosols. Use only with adequate ventilation. Keep away from heat, sparks, pilot lights, hot surfaces and open flames. Wash thoroughly with soap and water after handling. Keep containers closed when not in use. Keep out of the reach of children.

Storage: Store in a cool, well-ventilated area, away from incompatible materials. NFPA 30 Class IB Liquid.

Engineering Controls: Use in a well-ventilated area.

Personal Protection:
