4. First aid measures

Methods for cleaning up

7. Handling and storage

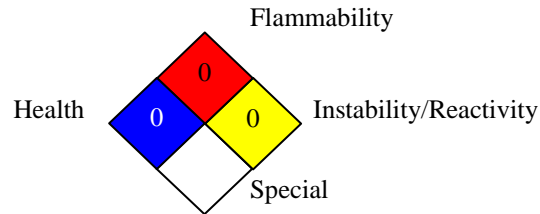
