4. First aid measures

7. Handling and storage

Use appropriate containment to avoid environmental contamination.

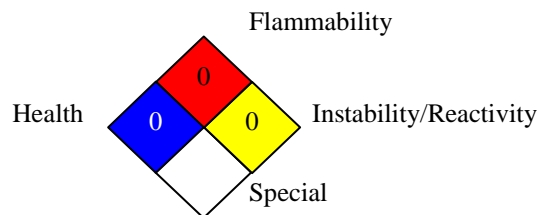
