SECTION 4 - FIRST AID MEASURES

- Inhalation** : If inhaled, move to fresh air. If irritation persists, seek prompt medical attention.

SECTION 6 - ACCIDENTAL RELEASE MEASURES

- Personal precautions** : Restrict access to area until completion of clean-up. Wear suitable protective equipment. For personal protection see section 8.
- Environmental precautions** : Do not allow product to enter waterways. Do not allow material to contaminate ground water system.
- Spill response/cleanup** : Ventilate area of release. Eliminate all ignition sources. Stop spill or leak at source if safely possible. SECTION 7 - HANDLING AND STORAGE

- Safe Handling procedures** : Wear suitable protective equipment during handling. Use with adequate ventilation. Training the workers on the potential health hazards associated with product vapor, dust or fume is important. Secondary inhalation exposures could occur when cleaning equipment, or when removing or laundering the clothing. Avoid breathing vapors, fumes or dust. Avoid contact with skin, eyes and clothing. Keep away from heat and sources of ignition. Keep away from oxidizing materials. Avoid and control operations which create high vapor or dust concentrations. Keep containers tightly closed when not in use. Wash thoroughly after handling.
