## Section 4. First-aid measures

### Description of necessary first aid measures

- Eye contact** : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention.

- Appropriate engineering controls** :
- Good general ventilation should be sufficient to control worker exposure to airborne contaminants.
- Environmental exposure controls** :
- Emissions from ventilation or work process equipment should be checked to ensure they comply with the requirements of environmental protection legislation.
