Section 6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

- For non-emergency personnel** : No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Provide adequate ventilation. Wear appropriate respirator when ventilation is inadequate. Methods and materials for containment and cleaning up

Precautions for safe handling

- Appropriate engineering controls** : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.

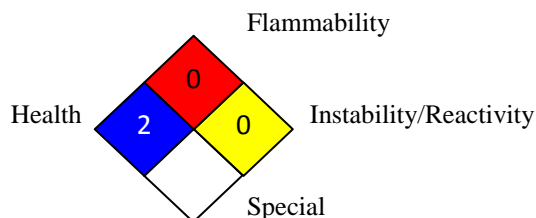
