### 4. FIRST AID MEASURES

**Description of first aid measures**

**Methods for containment** Prevent further leakage or spillage if safe to do so. Cover powder spill with plastic sheet or tarp to minimize spreading and keep powder dry. Do not add water to spilled material. Using clean dedicated equipment, sweep and scoop all spilled material, contaminated soil, and other contaminated material and place into clean dry containers for disposal. Do not close containers containing wet or damp material. They should be left open to disperse any hazardous gases that may form.

**Methods for cleaning up** Use personal protective equipment as required. Cover powder spill with plastic sheet or tarp to minimize spreading and keep powder dry. Take up mechanically, placing in appropriate containers for disposal. Avoid creating dust. Clean contaminated surface thoroughly. Pick up and transfer to properly labeled containers. Sweep up and shovel into suitable containers for disposal. After cleaning, flush away traces with water. Do not use floor sweeping compounds to clean up spills. Do not transport wet or damp material.
