Identified uses

Ultimate Copper Gasket Maker & Sealant is an RTV (Room Temperature Vulcanized) Silicone gasketing material designed for use in mechanical assemblies where high torque or closely spaced bolt profiles can lead to higher loads and cause gasket and sealing failures for average silicones. Curing occurs when the product is exposed to moisture in the air. The silicone then forms a tough, waterproof, gasket (seal) on most surfaces. It will not shrink or crack, resists oil and petroleum products, resists weathering, is sensor safe, and has good temperature resistance up to 700° F intermittent. It's great for many automotive applications.

Section 4. First aid measures

Description of necessary first aid measures

- Eye contact** : Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention.
- Inhalation** : Remove victim to fresh air and keep at rest in a position comfortable for breathing.
