**SECTION 2 - HAZARDS IDENTIFICATION**

**EMERGENCY OVERVIEW:**

**POTENTIAL HEALTH EFFECTS:**

**Dark Shades:** Water, Mineral Oil, Isopropyl Palmitate, Propylene Glycol, Talc, Stearic Acid, PEG-20 Methyl Glucose Sesquistearate, Methyl Glucose Sesquistearate, Diazolidinyl Urea, Fragrance, Magnesium Aluminum Silicate, Triethanolamine, Trisodium EDTA, Xanthan Gum, Propylparaben, Cetyl Alcohol, Methylparaben, Titanium Dioxide, Iron Oxides
