SECTION 4 - FIRST AID MEASURES

- **Eye:**

Following accidental eye exposure, thorough rinsing of the affected area for 15-20 minutes with clean, cold water is recommended. If discomfort or irritation persists, contact a physician. If the eyes or face becomes swollen during or following use, consult a physician or emergency room immediately.

- **Skin Problem:**

Thoroughly rinse with water. Discontinue use of product. If discomfort persists and/or the skin reaction worsens, contact a physician immediately. In cases where discomfort persists and/or medical attention is sought, do not use hair color products again until the specific nature of the skin reaction and the causative agent has been identified by a dermatologist, and appropriate medical advice provided.

- **Inhalation:**

- **Ingestion:**

Accidental ingestion of product may necessitate medical attention. In case of accidental ingestion dilute with fluids (water or milk) and treat symptomatically. Do not induce vomiting. SECTION 5 - FIRE FIGHTING MEASURES
